We use a method called "average daily balance (excluding new purchases) (including new balance transfers and cash advances)."

Promotional Period for Introductory APR:

The Introductory APR for purchases and balance transfers will apply to transactions posted to your account until 12/31/2024. Any existing balances on Alpena Alcona Area Credit Union loan or credit card accounts are not eligible for the Introductory APR for balance transfers.
